However, after a continuous period of 2 years as an insured person, all pre-existing conditions may become eligible for benefit provided you have not:

- a. experienced and or suffered from any signs or symptoms, whether investigated or not;
- b. sought or received advice;
- c. been recommended to have, or have received medical treatment, including lifestyle changes and special diets, drugs, medication and injections.

We may be required by law to collect certain personal information about you, or as a consequence of any contractual relationship we have with you.
